The Council decided to commission this voluntary assessment as part of its commitment to developing best practice and being a learning organisation.

Oxford Strategic Partnership key stakeholders and partners were invited by the peer team to help provide insight and inform the peer team on-site review assessment.

### 2. Welcome and apologies

o PJ left the meeting and Cllr Brown took the Chair.



## 3. Draft minutes of the last meeting & matters arising

Minutes of the last meeting were agreed.

## 4. Oxford City update (Caroline Green & Mish Tullar)

- Update communicated.
- **5. Health Focus -** Update on the key findings of the Oxfordshire Joint Strategic Needs Assessment (JSNA)
  - Presentation delivered by DM.
  - DM advised that Woodfarm and Lye Valley areas of the city (Churchill ward) are expected to be areas of focus for future work.
  - Comments shared included:
    - Opportunity and further potential for good overlap, and that the City is in a good place to sit alongside, the wider determinates of health and the housing agenda (e.g. regulation of all private sector rental, housing condition, authorities own housing stock condition, affordability, etc.).
    - Opportunity for further extending the MECC work stream (making every contact matter).
    - As major partners and employers in the city, there are more things that can be tapped into for workplace offers e.g. workplace wellbeing, mental wellbeing, package/s of physical activity, and that there may be scope for delivery.
    - Is there / can there be data insights on types of housing and standards of such in future needs assessments.

## 6. Oxford City Council Corporate Strategy 2024/28

- MT provided a key strategic headline update of the workshop feedback collated from the previous meeting.
- General consensus from feedback was that the City Council is not far off the priorities within the 2020/24 Corporate Plan. As such, that evolution of these were suggested for the 2024/28 Corporate Plan development. Alongside, a fifth priority of 'Well-run Council'.

#### Housing priority - comments:

- Their remains a City Council desire to continue to work with others as well as we can following the collapse of the Oxfordshire 2050 plan. Furthermore, there is a statutory duty to cooperate (e.g. Districts).
- Opportunity for integrated approach to homelessness.
- Affordable living is not necessarily just Council housing stock.
- o <u>Economy priority comments</u>:
  - Employment, education and training, and public transport are important.
  - Recruitment focus was perceived to be city centre focused more needs to be focussed within and with communities.
  - There is a change in climate of retail uses. Footfall in the city is circa 13% below pre-pandemic.



## o <u>Thriving Communities – comments</u>:

- Opportunity for more collective work linking in with the JSNA insight presented by DM.
- The City Council is already working on developing and implementing colocation opportunities (e.g. Public Health NHS & Leisure facilities).
- Cost of Living is impacting on many of the 'squeezed middle'.
- Precarious tenure in the housing Private Regulated Sector.

### Zero Carbon – Comments:

- Keep on going with the Zero Carbon Road Map and partnership work streams.
- Promote good practice and good work of the Zero Carbon Oxford Partnership.
- Increase work on bio-diversity (note: landowner responsibility).
