2. Draft minutes of the last meeting & matters arising

- Minutes of the last meeting were agreed.

3. Oxford City Council update

(Caroline Green – Chief Executive, Oxford City Council)

- Update shared, focus items included:
 - Change in the Council's political makeup (change in the breakdown of Members, Labour administration manifesto continues, no impact on Officer's work who work for all, some changes to Council Committees, are to be confirmed)
 - 2024/2025 Budget Setting (A significant challenge for the Council, with pressures from utility costs, inflationary increases, increasing homelessness and temporary accommodation costs and increase in construction costs. The strategy continues as generating income and finding efficiencies. Consultation is due to commence December 2023, with final Budget decision by Council in February 2023.
 - Impact in the City and Communities from conflict in Gaza and Israel (Faith and Community groups have jointly been meeting. A Vigil for Peace is taking place in Broad Street, Oxford on Sunday 5 November 2023 – those from all or no faiths, backgrounds and understanding are invited to attend).
 - Homelessness increases are showing to be almost 100% and temporary accommodation increases at 70% (higher than that in other areas); despite work well done by the Council and strategies to mitigate they are continuing to rise. The exodus of asylum seekers from hotels in the city will add to the pressures. The Council is looking to extend the Public Rental Sector scheme and asking landlords to work with the Council for options for more temporary accommodation in the City.
 - The Park and Ride combined ticket in partnership with Oxfordshire County Council has been extended to April 2024, an initiative that is also designed to help reduce congestions in the City. Other initiatives are being brought through the Councils 2024/2025 budget setting process.
 - The BMW investment in Oxford and Swindon demonstrates their commitment to EV from Oxford.
 - The Council received a good report from the July 2023 Local Government Peer Challenge Review.
 - The City Centre is showing a positive trend of recovery from the pandemic with numbers of 8.5m being recorded.
